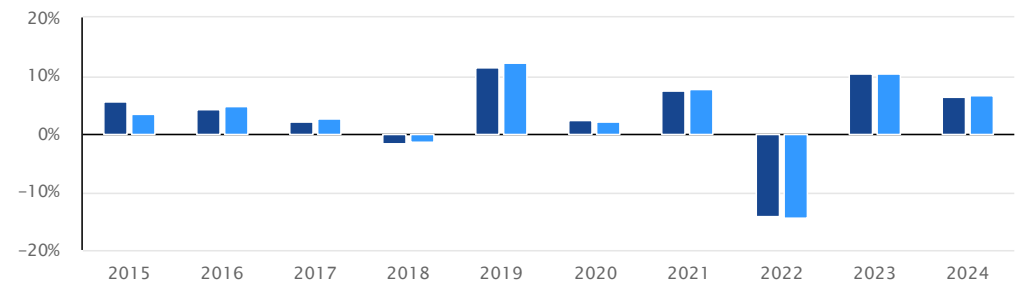
### Fund Description
